

Pacific Premier Bank is proud to offer FFA/4H financing to the Future Farmers of America and 4H members for the purpose of financing **one animal project** per student, per school year. Please refer to the guidance below when submitting an application for project financing.

We will require the animal to be insured. Insurance may be obtained through personal resources or the student's FFA/4H leader may have information regarding livestock insurance.

Maximum Loan amounts available per animal are detailed below:

- Market Hog, Market Lamb, Market Goat UP to \$1,000.00
- Market Steer and Replacement Heifer UP to \$2,000.00

Step 1: Complete the Application for Future Farmers of America or 4H Club Projects and obtain required signatures:

- Provide the student information at top of page
- Complete the Reasons for this loan and Budget Worksheet
- Obtain recommendation and signature of Teacher/Club Leader
- If the student is less than 18-years of age, the Approval of Parent/Guardian section must be completed

Step 2: Complete the Future Farmers of America/4H Business Loan Application and obtain required signatures:

- The Loan Applicant must be 18-years of age or over. If the student is less than 18-years of age, then the Application must be completed by a parent(s) or Guardian(s)
- If the student is 18-years of age or older, they may complete the Application
- Provide all requested information and sign where indicated

Step 3: Obtain insurance on the animal.

• Insurance may be obtained through personal resources or the Teacher/Club Leader may have information regarding Livestock Insurance.

Step 4: Provide the following to any Pacific Premier Bank branch:

- Completed FFA/4H Project Application
- Completed FFA/4H Loan Application
- Completed copy of insurance application

Upon receipt of a completed application package, a decision will be rendered within approximately 5-7 business days. If approved, the Loan Officer will be in contact to schedule a date to sign loan documents. Funding will be made by bank deposit to the Applicant's Pacific Premier checking account. New customers should open the account prior to, or at the time of loan document signing.

Please be advised that this loan will mature approximately 30 days after the Fair Auction. At that time, the loan plus all accrued interest will be due and payable in full.
